- Leaving school grounds
- Vandalism
- Weapons
- Leaving the classroom without permission
- Major breach of 'Online User Agreement'

Teacher Response

Step 1

- Student given time to cool down
- Outline specific behaviour from 'Pink Slip'
- Re-state expected behaviour from matrix
- Complete 'Pink Slip' for referral to office
- Student to administration



Administration actions Step 2

- Problem solve with student
- Determine resolution and consequence
- Enter Data
- Administrator follows through on consequence eg: assist teacher to implement informal contract
- Administrator informs parent/guardian and teacher



Third Office Referral

- Parent interview
- Consideration of Behaviour Support Plan

Some students will have individualised plans that may result in a different, negotiated process.

Severe Clause: Any student who engages in behaviour that poses a perceived threat to their own, or another person's safety, is at risk of damaging property, uses offensive language or demonstrates continual/ongoing noncompliance may be fast tracked through the process.
